





That may be however long the bureau determines. There is no recourse for this action of confiscation or arrest in this law. The Soviet (USSR) Politburo is conceptually similar. It spied on whatever citizens were deemed a threat, took their livelihoods away, stripped them of their liberties, and sent them to Gulag detention centers, potentially as life imprisonment.

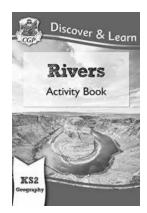

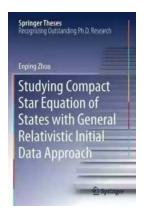

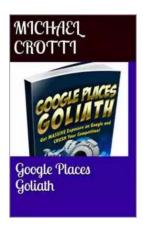
