

#### **Qualifying for Lemon Law Protection**

In order to qualify for protection under The Colorado Lemon Law, your vehicle must meet the following criteria:

- The vehicle must have a nonconformity, defect, or condition that substantially impairs its use, value, or safety.
- The nonconformity must have occurred within the first year of ownership or the first 12,000 miles, whichever comes first.
- The manufacturer, its agent, or authorized dealer must have been given a reasonable number of attempts to repair the nonconformity.
- The manufacturer, its agent, or authorized dealer must have failed to repair the nonconformity after a reasonable number of attempts.

### What Constitutes a "Reasonable Number of Attempts"?

The Colorado Lemon Law defines a "reasonable number of attempts" as:

- At least four attempts for the same nonconformity
- At least two attempts for a nonconformity that poses a substantial risk of death or serious bodily injury

If your vehicle has undergone a reasonable number of repair attempts but still remains defective, it is recommended to contact an experienced lemon law attorney to guide you through the process of filing a claim.

#### Filing a Claim Under The Colorado Lemon Law

If you believe your vehicle qualifies for protection under The Colorado Lemon Law, you need to follow these steps:

- Keep detailed records of all repairs and service visits related to the nonconformity.
- 2. Notify the manufacturer of the vehicle of the defect in writing, both by certified mail and regular mail.
- 3. Allow the manufacturer a final opportunity to repair the nonconformity.
- 4. If the manufacturer fails to repair the nonconformity or provide an acceptable resolution, consult with a lemon law attorney to file a claim.


